After interviewing Barbara Ebel, CM O'Connell made a motion, seconded by CM Conway, to re-appoint both Barbara Ebel and Glenn Fieldman, to the Open Space and Ecology Committee for terms through January, 2020. The motion carried unanimously by all present.

After interviewing Susan Maynard, CM O'Connell made a motion, seconded by CM Conway, to re-appoint Susan Maynard to the Complete Streets Safety Committee for a term through January, 2020. The motion carried unanimously by all present.

After Councilmember interviews of each candidate, CM O'Connell made a motion, seconded by CM Conway, to reappoint Renee Marmion to the Parks and Recreation Commission for a term ending in January 2020, reappoint Bonnie Bologoff to the Parks and Recreation Commission for a term ending in January 2018, and to appoint Kevin Fryer and David Drutz to the Parks and Recreation Commission for terms ending in January 2020. The motion carried unanimously by all present.

Councilmembers also discussed appointing Lillian Markind to the Complete Streets Safety Committee. They asked City Clerk Spediacci to contact her to see if she was interested in serving.

CM O'Connell made a motion, seconded by CM Davis, to appoint Lillian Markind to the Complete Streets Safety Committee for a term expiring in January 2020, pending her approval. The motion carried unanimously by all present.


4. Discussion of Planning Commission Applicants
